MINUTES FOR THE CLINTON COUNTY COUNCIL MEETING August 12, 2025

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on August 12, 2025, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. Council President Alan Dunn called the meeting to order and led the Pledge of Allegiance. On call to order the following members were shown to be present or absent.

Britt A Ostler, Clinton County Auditor, was present to record the proceedings of the Council. Tim Elston was also present to broadcast the meeting virtually.

Council member Chynoweth moved, seconded by Council member Mink, to approve the minutes of the July 8, 2025, regular meeting. Motion carried 6-0. Council member Corrie abstained.

COMMUNITY CORRECTIONS

Director Brett Barton stated there were 90 clients on electronic monitoring in July 2025, with 3 of those being juveniles and 1 on CTP. There is currently 1 individual on Pre-Trial Release. They received results of their Fiscal Audit with the State; no findings. All renovations in their new location are complete. President Dunn asked about the appropriation to be approved at today's meeting regarding a new vehicle purchase for his department. Mr. Barton stated that it has been purchased and their oldest vehicle was traded in.

PROBATION

Ember Morris submitted the Probation report for the month of July 2025 showing expenses of \$1,545.00. 3 juveniles were detained, but have since been released. 2 are on home detention.

NEW BUSINESS

Proposal to Add More Options to Beacon Schneider Program – Jada Ray, County Assessor, spoke regarding the update to the Beacon program. Beacon is a public website currently utilized by the public and County employees to obtain information on County parcels. This update would include 12 different layers to the program. These different layers would provide more self-serve options for the user regarding parcel history, deduction documents and applications, along with other beneficial services.

The initial cost set-up cost of \$15,143.00 could come from the Sales Disclosure Fund.

Upon motion by Council member Mink, seconded by Council member King, a motion to proceed with purchasing extra Beacon layers, passed 7-0.

Circuit Breaker and Maximum Levy Figures for 2026- Britt Ostler, Auditor

Per state statute, Auditor Ostler presented the circuit breaker and maximum levy reports and figures to the County Council for their review.

Upon motion by Council member King, seconded by Council member Price, the Council confirms that the 2026 Circuit Break and Max Levy reports were presented and reviewed. Motion carried 7-0.

Council reviewed the Monthly Budget Status and Financial Reports for July 2025. Council member Chynoweth moved, seconded by Council member Hensley, to approve said reports. Motion carried 7-0.

COUNCIL REPORTS

Council member Price is still working on the funds for the Mental Health (Community Howard). We have received an invoice for 2025 for over \$200,000 with no or little service from Community Howard. State Board of Accounts has advised that the County speak with an attorney.

President Dunn, Council member Price and Council member King all attended a joint session with the Boone County Council, at the Boone County Annex, to hear from Ryan Hoff of the AIC. He spoke regarding the legislative changes to SB1 and how those changes might affect our Counties.

COMMISSIONER REPORTS

Bert Weaver reported he isn't sure when the Courthouse will be moving to the Annex. Issues with front sidewalk/approach and inside punch list are not getting resolved in a timely manner.

DEPARTMENT HEAD REPORTS

SHERIFF - Rich Kelly gave the Council an estimate to upgrade to the current jail computer system. It's also recommended that the air and water be tested by a third-party vendor after the system is installed. \$173,089 is cost for new system. Approximately the same amount to replace all the actuators. It had precious been discussed to use the LIT Correctional Facility supplemental distribution to cover these expenses.

Upon motion by Council member Root, seconded by Council member Price, a Motion to use the LIT Correctional Facility supplemental distribution for these expenses/repairs carried 7-0.

Matron Kelly requested the use of Commissary funds to cover the \$3891.40 cost of repairing one of the commercial dryers.

Motion by Council member Corrie, seconded by Council member Hensley, to use Commissary money to pay for said repair. Motion carried 7-0.

EMA – Temporary Director, Renee Crick, reported that the annual EMA advisory meeting is next week, August 19, 2025. The advisory board is made up of the City and County officials

The morgue sits on the east end of the EMA building, but the Coroner vehicles are currently kept in the middle of the building. The Coroner and EMA Director are getting bids to put in door so the Coroner could more easily access the garage on the East end of the building and thus park his vehicles down there. It's a way more efficient use of the building.

BOH - Melissa Ostler, Health Department, spoke regarding getting the word out for what the health dept does for the community. The steps for the campaign are in the works. Carol Price went to Montgomery County with the Health Department to meet with Dr. Adams and Ann Hazelet from the State.

EMS – Director Deckard informed the Council that his department had received a \$5000 grant from Duke Energy. These funds will be used for active shooter training.
